

Technical Appendix 6.1: Cultural Heritage Assets within the Inner Study Area (EIA Report Volume 2a, Figure 6.1)

1.1 Introduction

- 1.1.1 This Technical Appendix (TA) provides details of the heritage assets recorded within the Inner Study Area (Application Boundary¹), identified through desk-based assessment and walkover field survey, together with an assessment of their heritage sensitivity. These are identified in **Table 6.1.1** below.
- 1.1.2 The locations, and extents, of these heritage assets are shown on **EIA Report Volume 2a, Figure 6.1**
- 1.1.3 This TA should be read in conjunction with **EIA Report Volume 1, Chapter 6: Cultural Heritage Assessment.**
- 1.1.4 The criteria for assessing the heritage sensitivity of each asset are set out in **Chapter 6, Section 6.4** and **Table 6.2**, and draws on the guidance provided in the SNH/HES Handbook (2018)².
